# How will it work?

## 2024-2025 School Year

Birthdays between September 2, 2019 and June 2, 2020

- A child will enroll in Arete Charter Academy (ACA) and your preschool will become a vendor for our charter
- Arete will pay \$2,500 toward preschool tuition for the remainder of the school year (January—June)

### What will the parents have to do?

Parents will have to attend a 20 minute meeting every 20 school days where work samples and an attendance sheet are collected by an ACA Educational Advisor. There are five learning periods remaining in the year (hence, five meetings). These meetings can be held near the preschool (e.g. a local Starbucks).

### What do the parents benefit?

\$2,300-\$2,500 of their child's preschool learning experience will be funded by the Arete Charter Academy's educational stipend.

### What will the school have to do?

- Provide ACA with proof of liability insurance
- Employees must be TB tested (we can assist with this)
- Sign an agreement with ACA that stipulates that all employees are fingerprinted
- Facilitate the gathering of work samples for the students (this can be as simple as gathering 4-5 work samples each learning period)

### How does the your school benefit?

## 2025-2026 School Year

Birthdays between Sept. 2, 2020 and Sept. 1, 2021

- A child will enroll in Arete Charter Academy (ACA) and your preschool will become a vendor for our charter
- Arete will pay \$4,500 toward preschool tuition throughout the school year (\$1,500 for Aug—mid-Nov, \$1,500 for mid-Nov-Feb, \$1,500 for Feb-June)

### What will the parents have to do?

Parents will have to attend a 20 minute meeting every 20 school days where work samples and an attendance sheet are collected by an ACA Educational Advisor. There are nine learning periods throughout the school year. These meetings can be held near the preschool (e.g. a local Starbucks).

### What do the parents benefit?

\$4,200-\$4,500 of their child's preschool learning experience will be funded by the Arete Charter Academy's educational stipend.

### What will the school have to do?

- Provide ACA with proof of liability insurance
- Employees must be TB tested (we can assist with this)
- Sign an agreement with ACA that stipulates that all employees are fingerprinted
- Facilitate the gathering of work samples for the students (this can be as simple as gathering 4-5 work samples each learning period)
